As per discussed with Administrator, the protective surfacing (pea gravel) that has been recently added to the Infant/Toddler outdoor play space is unsafe for this age group. This must be removed immediately as it poses a safety issue as this age group often puts objects in their mouths. Two different surfaces are required in outdoor play areas. It is recommended to use more than one type of surfacing to permit different types of play. For example, a soft cushion rubber type mat, grass etc. I also mentioned below the gate needs adjusted. Please remove the pea gravel on or before Friday, July 23. Please supervise children closely while in the playspace. The owner stated that she would be addressing this evening. Please email and send a picture when this has been completed. Ty

Monitoring visit performed.

Administrative records were reviewed. Attendance is being tracked daily, Staff records were reviewed to verify training and this was documented. All staff have either completed 1 year ECE training, the 90 hour training, or currently enrolled in 1 year certificate ECE program and will graduate in June 2022.

Playground checklist is being tracked and please add the year on the checklist. TY

I observed that outdoor toys, equipment need a good cleaning and stored when not in use.

Children were observed in outdoor play during my visit. The shade sails need to be tied tight so staff can also access underneath where children play. They are currently too low to walk under.

Diaper change mat needs replaced in one of the rooms as it is torn. It is difficult to clean and sanitize. Please purchase a new diaper change mat. TY.

Sensory materials like pasta - ensure children are washing hands prior to use and change this material up weekly.

The gate in the infant/toddler play area that opens into the preschool play space needs adjusted so the opening in less than 3 inches as it poses a safety issue. See comment above regarding the pea gravel that must be removed from this outdoor play area. This will also address the issue of the play pen being used in the infant

toddler play space. A rubber mat maybe more suitable and provide young babies more space to move around than being confined to a playpen.

Children were observed eating lunch and going down for a nap for those that do. Some children enjoy a quiet time.

Staff were observed engaged with the children, assisting with lunches, diaper changing and getting ready to settle down for napping. Older preschool age children enjoying a variety of age appropriate activities. I asked educators to label the javix and water spray containers.
