General Comments

A renewal inspection was conducted today. Certificate of General Liability Insurance is required.

Children were observed in the following areas: Snack, inside play, outside play, and lunch.

The educators have divided the group of children in 1/2 during story/circle time. While one group goes outside for their story time the other group remains inside. The group inside were observed in a very interactive circle time: hunting for the color orange, identifying objects with their learning environment, making a geo-board (from a pumpkin) then creating designs by using elastics to connect the pegs.

Educators were observed asking open ended questions to the children and using tier three words (utilizing). She told the children they were utilizing the stem of the pumpkin as a nail. She then asked the children what they thought that meant. The children answered with "using".

Educators were observed having meaningful conversations with the children both in the inside and the outside environments and speaking respectfully and kindly to them.

Children's art and learning are displayed throughout the centre as well as on the walls in the hallway.
