General Comments
<p>A Monitoring Inspection occurred August 2025</p> <p>The children were observed during indoor free play, which included playing with toy trains, role-playing as a family in the dramatic play area, going down the slide, and looking at books. The educator indicated that the children are currently interested in toy trains, open-ended art, feeding the class pet fish, Periwinkle, water play, and going for walks.</p> <p>The children shared a documentation book on Rainbow Sparkles' adventures. The educators shared that the class each takes turns taking Rainbow Sparkles, the stuffie, home along with the class book to document Rainbow Sparkles' adventures.</p> <p>Several forms of documentation were visible throughout the room, including photographs, learning stories, and children's artwork. Books were selected to reflect the children's interests.</p> <p>Traffic areas, both indoors and outdoors, were maintained in a clean and clutter-free condition. A clearly visible and prominent area was designated for posting the facility license, current monitoring reports, and any orders for compliance. Additional documents reviewed included incident logs, daily attendance records, and records of evacuation and monthly fire drills.</p>

- Educators are to ensure that outdoor play occurs daily for each four-hour block of time.
