## **General Comments**

When I arrived for today's visit, the children were finishing up snack and playing freely around the room. While the operator was giving me a tour of the children's play space, the children spotted suitcases in the storage room. Operator followed the children's new interest and let them take out the suitcases and explore them. The suitcases went from being little beds, to being real suitcases that the children were packing to go vacation, and then they turned into cars!

The operator was observed interacting with children and being attentive to their needs. Gentle reminders and redirection techniques was observed during today's renewal inspection.

Children went outside to slide after quiet/nap time.

Children can pick their blankets they wish to use during nap/quiet time every day. Operator ensured that all blankets are washed nightly so they are ready to go for the next day.

Operator permitted children to watch children's music videos on television during lunch and quiet time. A reminder that the use of television viewing must be limited and not used daily.

A reminder that it is not recommended for children to share food from their lunchboxes during mealtimes for safety reasons such as possible unknown allergies. It is recommended that operator sit at the table with children while they are eating to help model healthy eating practices.
