## **General Comments**

When the QA Monitor arrived one staff member was on the main floor, supervising 3 preschoolers who were napping in the preschool play space, and she was also responsible to supervise the 2 infants who were sleeping in the infant sleep room. Another educator was on the second floor with 4 school age children and 1 preschool child who was not napping. Staff advised that the preschool and school age children were together today due to low numbers but the staff assigned to that group took the non-nappers upstairs to provide a quieter rest time for the napping children. By leaving the 3 preschool children in the care and supervision of the infant educator during nap time, this placed the infant educator over ratio.

Licensing Regulation. This must be completed and placed in her file.

## **General Comments**

The other educator returned to the main floor with the preschool and school age children and she resumed supervision of the sleeping preschool children. The ratios for the 4 school age and 4 preschool children, who are present today, does permit for one educator. This corrected the ratio deficiency noted above.

Staff must maintain supervision of the children at all times, one staff member cannot be responsible to supervise the napping children in two different rooms and infants are not to be part of a mixed age group. Room capacity must also be respected at all times.

After nap time the staff plan to take the children outside. The outdoor play space is large enough to accommodate both groups at the same time, the infants have an area designated within the larger space. The outdoor area at this facility has a good variety of materials and equipment and lots of room for the older children to run around.
