This information must be completed daily by educators for all children under 24 months and to enter any comments that might be assist with the management of illness. Please commence going forward. I will follow up on the next routine visit to ensure these records are being completed daily.

Comments:	Licensing staff observed a few items that need addressed in outdoor play area. The fencing on the left side needs fencing ties, and a blue splintered box needs removed from the play area as this could pose a safety concern with splintered in little fingers. Please store small toys away at the end of the day, so they don't end up freezing to the ground and become a tripping hazard.							

General Comments

Annual inspection performed.

Upon arrival children were finishing snack and getting ready for outdoor play. Please remind parents to send children with proper outdoor foot ware. Licensing staff observed one child wearing rubber boots.

Administrative records were reviewed - child records, child and staff attendance is being documented daily, fire drills are being practiced and documented monthly, outdoor check list is completed monthly, potential illness reports and incident reports are recorded and signed off by parent, so they are aware.

Staff files were also reviewed and Licensing staff verified that 6 staff (over 50%) have completed the 90 hr Intro to ECE. A few staff have either been registered or enrolled for the next 90 hour Intro to ECE course. Currently this centre is meeting this section of the legislation. However, read comment above regarding the staff that are currently enrolled in the 1 year ECE program.

All children were observed in outdoor play, eating snacks and lunches at routine times and going down for nap. The older preschool children were involved in quiet play opportunities during my visit.

Just a kind reminder for staff to be documenting arrivals on the attendance record and when they leave the centre. Two staff left during my visit and did not sign themselves out. I will follow up during my next routine visit.
