Comments: A doll house has been recently added to the indoor environment. Many of the children have been showing an interest within this area, but it is lacking in accessories/props to support this interest. Additional furniture, clothing, accessories to be added.

Comments: Materials were lacking within the creative art area today. There was a variety of creative art materials (ex: glue, colored paper, decorative pieces, popsicle sticks, etc.) organized within and on top of the cabinet in the room, however these were not out and accessible to the children. Ensure that a variety of materials are taken out of the cabinet and set up within an accessible area/shelving unit for the children. Discussed with educator on site.

Comments: One of the wooden stools within the room located beside the foosball table has some nail heads sticking out on side of the seat. To be repaired or replaced. Some of the green bins within the toy storage unit are collecting dust/debris and are in need of cleaning.								
General Comments								
Renewal inspection completed today. The children were observed within their indoor and outdoor environments. Hand washing and snack time routines were also observed. The children enjoyed a healthy snack today (yogurt,								

with bran and berries and homemade banana bread).

The educators were observed to be engaged with the children and spoke to them in a respectful way. The

children have developed a "store" with their educators (inside a cabinet within the room) where they can cash in pretend money that they have earned throughout the week for prizes that they choose. The children take turns "running" the store and appeared to really enjoy this sense of responsibility. Other children were engaged with beading, building/constructing with straws and relaxing in the cozy center today.

Many of the children have become very interested with their new yoyo's that they have received at school and were engaged in learning new skills with these today. How else could this new interest be supported within the environment?

Many photos of the children are displayed on poster boards within the hallway for the children to revisit past experiences. There is also a calendar displayed on the wall within the room detailing some activities for each day of the month (ex: make slime, games day, etc.). Ensure that this is based on the interest of the children. Recommending that the educators include the children in this planning process (ask the children questions about their interests, what materials they would enjoy exploring, and what props they would like to add or create within their environment).

The dramatic play area that had been designed as a market/grocery store appears to be attracting less attention than when it had been initially created. How could this be altered/rearranged to support a new interest?
