General Comments

Monitoring visit performed. One observation, please store the diaper change mat off the floor when not being used. Administrative records were also reviewed.

At arrival, the Operator and children were in the playroom located on the lower level. Children were playing with a sensory bin and examining materials regarding fall things - different colored leaves, pinecones etc Licensing staff observed recent programming activities posted - Matching, sorting shapes and colors, reading, building with a variety of materials etc. The Operator posts learning stories in the classroom at children's eye level so the children can look at the pictures and talk about them. The operator also posts the same to parents on a private FB page.

The play space is inviting, clean and organized and toys and materials are easily accessible to the children. The Operator recently has reorganized the children's area since my last visit just to change things up -cozy reading area, kitchen and art area and blocks etc. The Operator has also made a change to her service. She has finished the lower level and has added a kitchenette, a fridge to store children's lunches, and children's table and chairs for children to eat snacks and lunches and also a new bathroom. Everything is in one area which makes it easier for the Operator and children. They only need to go upstairs when getting ready for outdoor play. Only one child naps in a crib on the main level and all other children nap in the lower lever. This is lovely and very inviting.

Snack today was bear paws, sliced apples and milk. Lots of conversation and interaction during snack. The Operator encourages children to talk by asking them questions about their families. She uses playful conversation and encourages children to talk about things "can you say mama', ' how old are you". The operator tries to initiate conversation with all the children. ' do you go on the tractor with your daddy?'

The Operator offers a wonderful inclusive program. The operator has posted a weekly schedule which is shared with the parents and promotes active play with quieter indoor activities.

During story time - children are engaged. The Operator listens and asks children questions and talks about the story.

Lovely program this AM and children are enjoying their morning. They will also be going outdoors as the Operator indicated this in her conversation with the children.
