### General Comments

Upon arrival children were seated at a child size table. The operator has planned a painting activity with the pumpkins the children picked while on a field trip to an apple orchard yesterday. One child mentioned the trip to the orchard to licensing staff. They also picked apples!

Children's learning is posted in the centre in the children's play area, but the Operator also posts programming on a private parent FB page. The Operator encourages children to pick paint colors and assists with squeezing the paint on two palettes and assists with the painting process. The Operator engages and asks children questions while they paint the pumpkins - "What colors would you like to use - some yellow, purples, blue etc. yes you share the tray with your friends. Is that a good idea? Children respond with yes. The operator talks about the shape of the pumpkin. After clean up, children played with blocks and played in the kitchen centre. Before going outdoors, children were encouraged to help with clean up, then proceeded to have toilet break and get dressed in muddy buddies for outdoor play. The operator praised the children with helping clean up and said to the children "Awesome everyone".

Administrative records were reviewed - attendance, infant toddler records, staff info., fire drill record, outdoor checklist were reviewed. Please ensure you complete infant toddler records daily.

Children were observed playing on and under a small climber. Children climbed up on the ladder then would take turns sliding. Other children used shovels and pails to fill up with rocks to make pretend birthday cake for all their friends and they inserted sticks to represent the candles on the cake. Then the children sang individual birthday songs. There are lots of toys, equipment and natural materials to explore in the outdoor play area. Children came inside at noon, ate lunch and prepared to go down for a nap. The operator helped children with toileting and washing hands after lunch.

This operator provides a lovely program. The Operator is very engaged with children and talks to them constantly and interacts positively. Children are very happy and play cooperatively with each other.
