General Comments							

An operator of a licensed facility shall post in a clearly visible and prominent place on the premises: (a) the daily routine; (b) the weekly menus; (c) instructions regarding evacuation in case of a fire as approved by the fire marshal, deputy fire marshal or fire prevention officer; (d) the name of the administrator; (e) the name and telephone number of the inspector; (g) whether a child receiving services at the licensed facility has a life threatening allergy and a description of that allergy; and (h) if a child has or may be affected by a disease that is required to be reported under the Public Health Act and the regulations under that Act by the operator of the licensed facility, the disease that has been reported.

The above items should be moved to the entrance of the home so parents have access to this information daily.

General Comments

A copy of the evacuation procedures/plan should remain down in the play area also and near any emergency exit.

Please ensure a copy of social development and criminal record check is on site for all persons in the home 18 years old and up.

Please ensure that all staff files, child files, attendance records and all other required documents are organized and available for Inspectors to review.
