| Comments: Inspector observed that the year is not indicated on the staff member attendance records. This information was added to each sheet while Inspector was on-site. Deficiency is now compliant   |                           |                                    |                |

| Comments: Inspector found toxic products unlocked underneath the kitchen sink. A discussion was had with a staff member regarding ensuring that when staff are not present in the kitchen, both kitchen doors must be locked. During the inspection, inspector observed staff close the kitchen door when they were leaving.<br><br>Inspector also found toxic products on top of the paper towel dispenser in both washrooms used by the children. Educator placed these under lock and key immediately. Deficiency is now compliant |                           |                                    |                |

| Comments: During the Inspection, Inspector found 2 Administration of Medications Consent and Record Forms that were not properly filled out. One of the forms did not have the End Date of the administration of the medication indicated and one of the forms had a wrong date indicated. A discussion was had with a staff member regarding how to fill these forms out properly.   |                           |                                    |                |

| Comments: Inspector observed that not all lunch boxes and water bottles are labelled with the child's name. Operator must ensure that all water bottles and lunch boxes are labelled with the respective child's name. |            |                      |                |

**General Comments**

During the Renewal Inspection, Inspector observed outdoor play. Inspector observed an educator actively participating in the children's activity by pretending to drive in a vehicle with them. Inspector also observed children playing with puzzles, coloring and reading books. During this time, Educators were engaging with the children by building the puzzle with them and also looking through the books with them. Inspector also observed an Educator reading a story to the children before the rest period.

A conversation was had regarding new play equipment that has been added to the outdoor play area. Recommendation that Operator review manufacturing manual to ensure that the proper amount of protective surfacing is placed for this equipment.

Ratio was respected during the time of the Inspection.
