<p>Comments: The Quality Assurance Monitor had a discussion with the administrator regarding the protective surfacing requirement for the play equipment in the school age outdoor play area. The Quality Assurance Monitor asked the administrator if they have had a chance to verify if the equipment requires a protective surface. The administrator shares that they are having a contractor to some maintenance on the structure to make it more durable. The Quality Assurance Monitor reminded the administrator that it is their responsibility to assess whether the stationary equipment necessitates a protective surface and if the chosen protective surface aligns with the CSA standards as the structure does not have an instruction manual. The operator is also accountable for ensuring that the stationary equipment's construction adheres to the CSA guidelines. Once the administrator can confirm that the necessary verifications have been conducted by either the contractors or by themselves, in line with CSA guidelines, this element will be made compliant. The Quality Assurance Monitor is unable to certify compliance or the suitability of the protective surface if these verifications have not been completed. In the event of an incident involving the structure, it is essential to be confident that the installation adhered to the established standards and guidelines. A written confirmation can be sent to the Quality Assurance Monitor to indicate that a verification was complete and that the structure adheres to the standards.</p> <p>The administrator has confirmed that the children are not using the structure until the verifications and repairs have been complete.</p>
