Comments: Inspector observed that the children's departure time was not indicated on the daily attendance record for 2 children. This was addressed with the educators, who indicated the children's departure time immediately. Deficiency is now compliant

Comments: Inspector observed a yellow chair in the outdoor play area that is broken, making an area of it sharp. Staff indicates that the chair is currently frozen in the ground. Until the chair can be removed, Administrator must ensure that the chair is repaired in a way to reduce the risk of a child injuring themselves. Inspector also observed ice in the preschool play area as well as the school aged play area. Administrator must ensure that the play area is free of ice, in order to ensure the safety of the children.

Comments: Inspector observed insufficient art material in the Jr. Preschool classroom. Inspector observed scrap papers, a roll of drawing paper, chalk, crayons and 1 cardboard tube. A discussion was had with the educator regarding strategies to store the art material in order to ensure the safety of children.

Comments: Inspector observed that a pair of snowpants, a neck warmer, mittens and water bottles are not stored in children's personal storage spaces. Administrator must ensure that children's personal belonging are stored separately. Inspector recommends that the children have larger storage bin to store their personal belonging, in order to help ensure that all their belongings can easily fit in their respective bins.

Administrator must ensure that all required information be indicated on these.

Comments: Inspector observed that the administration of medication is documented. However, the start and end date that the medication was administered as well as the year that the medication was administered was not indicated. Administrator must ensure that all required information be indicated. The year was added to the documentation during the inspection.

Comments: 3 verified lunch boxes did not indicate the name of the child. Administrator must ensure that all food brought from home is labelled with the child's name.								

**General Comments** 

During the time of the inspection, Inspector was unable to observe whether or not there are 2 surfaces in the outdoor play area. This will be verified at a later date. Inspector was also unable to verify the protective surfacing of the stationary equipment, as the ground is currently frozen. A discussion was had with staff regarding the use of stationary equipment during the winter months. As per Section 10.4.10 of the CSA standards states: winter weather conditions reduce the effectiveness of surfacing material. These conditions shall be considered by the operator.

Inspector recommends that the emergency evacuation procedures and the children's allergies be posted on the parent board.

A reminder to ensure that the time of the children's return to the facility be added on the consents for special outings.
