Comments: During the renewal inspection, the inspector observed that the list of allergies that are posted in a visible area is not up to date. The administrator must ensure that life-threatening allergies is posted in a visible area. After a discussion with the administrator, a new updated list of life-threatening allergies within the facility is posted in a visible area. Deficiency is now compliant			
49(1) An operator of a licensed facility shall ensure that the guidance of the children receiving services at the licensed facility is positive and includes positive reinforcement, encouraging efforts and recognizing accomplishments.	49(1)	Jan 20, 2026	
Comments: The inspector seen a child express to an educator that they were sad and wanted to go home. The child was sitting in a chair, excluded from the other children dancing. The educator responded to the child saying "you're not going home!". The inspector has a conversation with the administrator about positive child guidance. These practices help to develop relationships that promote children's well-being and sense of belonging. Educators must use positive child guidance at all times. The administrator confirmed they will speak to the educator in question about positive child guidance as well as the Board of Directors.			
9(1) The child-to-staff ratio is one educator for each of the following groups of children of the same age receiving services at a full-time or part-time early learning and childcare centre: (a) three infants or fewer; (b) five children or fewer who are two years of age; (c) eight children or fewer who are three years of age; (d) ten children or fewer who are four years of age or older, but who are not yet attending school; and (e) 15 school-age children or fewer.	9(1)	Jan 20, 2026	Jan 20, 2026
Comments: During the renewal inspection, the inspector spoke with an educator. The educator left the classroom to ask the administrator for clarifications on the conversation held with the inspector. The inspector asked for the educator to remain in the classroom. Child-to-staff ratio must be maintained at all times. An educator immediately went into the classroom to watch the children. Deficiency is now compliant. Deficiency is now compliant			

## General Comments

During the renewal inspection, the inspector observed the children eating snacks, washing their hands, dancing with the educators and, getting ready for nap time. The inspector also observed the after-school kids playing with dolls and magnets and eating snacks.

The inspector observes that these items were not labeled with the child's name:

-□ 4 of 16 water bottles

-□ 2 of 10 lunch boxes

The administrator must ensure that the children's belonging is labeled. The inspector spoke with the educator who immediately wrote the children's name on the water bottles and lunch boxes.

The inspector observed that the diaper changing procedures are not posted in a visible place in the diaper changing area in 1 of 3 classrooms. The educator spoke to the educator who immediately posted the diaper changing procedure in a visible place in the diaper changing area.

The most recent monitoring inspection report is not posted in a prominent and visible place in the facility. Administrator must ensure that this information is added. During the renewal inspection, the administrator posted the recent monitoring inspection report in a visible area.

The inspector has a discussion with the administrator about the professional learning hours. The administrator must ensure that every eligible educator completes their 10 hours of professional learning before the end of the licensing term (February 28th 2026).

The inspector had a conversation with the administrator about the use of cell phones and the DOJO application. Administrator must ensure that staff use these tools efficiently and appropriately.
