General Comments							

General Comments

A Monitoring Inspection took place on July 23, 2024.

During the visit, children were observed engaging in both indoor and outdoor free play. Proper handwashing was noted during their transition indoors. Educators mentioned that the children are currently very interested in summer camp activities, community field trips, and outdoor activities.

In the facility, parents of the children present at the center are granted entry at any time. Snacks are provided every three hours, and meals are served at recognized meal periods. The daily and weekly routine is posted for visibility. Evacuation procedures are clearly posted in a prominent location. Toxic products such as chemical cleaners are securely locked and inaccessible to the children. The changing area is located within a meter of a sink, and diaper-changing procedures are posted and visible. The outdoor stationary equipment is surrounded by protective surfacing of appropriate depth.

General Comments

The curriculum offers opportunities for both individual and group experiences, with various forms of literacy present in the indoor environment. A conversation with the on-site administrator highlighted the strengths and needs of the facility. The strengths identified include community outings, opportunities for physical activity indoors and outdoors, and support for inclusion. However, some areas for improvement were discussed, such as purposeful planning of learning centers to encourage opportunities for creativity, exploration of the arts and sciences, experiencing accomplishments, problem-solving, and developing trusting, respectful, and supportive relationships.
