<p>Discussed the record keeping component of regulations with operator. Operator was advised that anything to do with child's file must be kept for 3 years after the child has left the facility. All other forms of paperwork can be kept for 1 year.</p> <p>Discussed incident reports with Operator. Minor incidents are being recorded. Operator stated that their has been no reportable incidents.</p> <p>There was no evidence of potential illness forms that were used. Operator stated that they have had to use them in the past but not recently.</p> <p>Operator is documenting children's experiences on a Facebook group and was advised to print out copies to keep on file for licensing staff review. They stated that learning stories and pictures are being used to keep parents informed. The licensing staff did observe scrapbooks with children's work in them. Please continue to develop your pre-planned programming and documentation. The scrap books are a great addition to complement the curriculum.</p>
