General Comments

Annual Inspection:

Educators have created an engaging and inviting environment both inside and outside for the children.

The inside play area has blocks, dramatic play and lots of toys for the children to engage and explore with. Children's learning is displayed throughout the room, the cubby area as well as the rest area.

The outside deck has created a space for the children to use push cars to drive on with a large umbrealla covering the deck on sunny days to provide ample shade. The grass area has a covered sandbox that provides shade to the children on sunny days. Musical instruments are attached to the fence for children to use to create music. The cozy corner a-frame is an area the children can explore for some quiet time if they prefer.

During inspection educators were observed speaking very kindly to the children and getting down to their level to re-direct behaviors appropriately.
