A renewal inspection occurred today.

Inspector observed the children during morning snack, inside play, outside play, lunch and nap/quiet time. Educators were observed down at the level of the children interacting with them in their learning and play. Inspector also observed the educators sitting with the children during lunch/snack time, tending to their needs. Discussed with the Administrator, professional learning for those educators currently taking the micro-credential ECE program that they are exempt from taking the required 10 hours of PL until the course is completed. Information regarding this, was emailed to the Administrator by the Inspector.

Inspector reviewed all staff and operator files and these were verified complete. A review of all children's files occurred and missing documentation was noted on the renewal inspection report.
