General Comments

When I arrived for today's monitoring inspection, there was a sign on the facility's door to inform parents/guardians that the children were playing at the Connaught School's playground. Upon arriving at the playground, educator informed Quality Assurance Monitor that she had given the children the choice to either return to the facility for lunch or eat at the playground. Children voted on staying at the playground to eat their lunch.

Once children finished lunch, they were able to play freely around the playground. Observed the educators constantly moving around the playground to ensure they could properly supervise the children. One educator was observed playing a game of "Grounders" with the children.

Observed all "Go-Go children" wearing green colored pinnies so that educators can easily identify them when there are other children playing in the same playground.

Observed educator asking the whole group if anyone needed a bathroom/refill water bottle run. Educator ensured ratio was always met during these bathroom/water bottle breaks.

Educators were noticing that some children were wanting to return to the facility, so they gathered everyone up and informed that they go back to play inside. Many children mentioned that they wanted to stay outside to play, educator brought the idea that they would go inside to play for a little bit, but then come outside again at the end of the day for pick up. Children agreed that it was good plan.

Before heading back over to the licensed facility, educator was observed performing two headcounts to ensure everyone was present and accounted for.

After returning to the facility, educators ensured all children washed their hands before doing a quick circle to see what the children wanted to play with. Children were observed coloring, doing crafts, reading, and playing several games of "Red Light, Green Light". Educator was observed supervising the game of "Red Light, Green Light", and also partook in the game.

General Comments

Educators were quick to comfort children when they were upset.

All staff files that were observed today were found to be in compliance with Licensing Regulations.

All required information that is required to be posted to parent/guardian boards, as outlined in Licensing Regulations, were observed to be posted at time of inspection.
