General Comments

A renewal inspection was conducted today. Children were observed in outside play and having snack. The indoor environment is set up with very defined interest centres and the children's learning is documented in the form of learning stories, pictures, art, and a binder of their activities has been created.

In the indoor environment the children have a rabbit and a fish and both the hutch and the tank were observed to be very clean.

In the outdoor environment, the educators indicated that they are working on creating defined interest centres. There is a covered sandbox, climbing structures, mud kitchen/dramatic play, basketball/sports area. The educators indicated they are getting more shade for the area to add to what they currently have as well as create a stage as the children are very interested in performing; either dancing or puppet shows.

During the inspection, conversations were had with the children as to what activities they have participated in this summer. They indicated they have gone to the park, the high school for a games day, walks for ice cream and exploring the areas around the child care facility. The educators were observed having meaningful and respectful conversations with the children and the children were observed laughing and appeared happy and
