General Comments

Both school age and preschool classrooms had to unfortunately cancel their fieldtrip to the splash pad today due to the weather and were therefore playing inside during today's inspection. All educators ensured that they had fun indoor activities planned for the children to do since they could not go to the splash pad.

The preschoolers were all sitting down enjoy a story while the after schoolers were playing freely around the room when I arrived for today's inspection.

The preschool children got the chance to paint with their feet today! One educator helped the children get paint on their feet by holding their hands while they stepped in a container of paint, they then got to walk across a large piece of paper making footprints, while another educator was waiting for them at the end with a bucket of water and a towel to help them wash the paint off their feet and dry them. This activity lasted quite a while as the educators let the children take as many turns as they wanted. The children appeared to really enjoy this activity!

After lunch, the preschool children enjoyed a nice story and then got to chose what quiet play invitation table they wanted to play at. They got to chose from building block, coloring, magnetic blocks, crafts, and linking blocks. Educators also turned on some quiet and relaxing music for quiet time.

The school age children were observed playing a game of minefield. There was a grid tapped on the floor and someone mapped out the safe and not safe squares that the other children could step on. If a friend walked on a square that was "safe", then they could keep on going, if they walked on a "not safe" one their turn was over, and it was on to the next person to try and make it safely across the "minefield". The children who did not wish to participate in this activity were observed doing crafts or playing board games. Educators and children were observed cheering on the children as they took their turns. Observed children helping each other out to safely get across.

After lunch, the school age educators turned off the lights, turned on some quiet relaxing music and children got to choose some tabletop activities to do. Some activities that the children were observed doing were crafting material, Lego, blocks, card games and board games.

General Comments

I observed lots of positive child guidance such as gentle reminders and positive reinforcement in both rooms. The educators in both rooms are attentive, engaged and respectful with the children and are often observed playing with them.

Everything is in compliance and I recommend for renewal.
