One educator informed me that she completed her Early Childhood Education course last year. Her certificate was not in her staff file. I contacted Go-Go's head office and they were able to provide me with proof of her ECE completion.

Please ensure to have it printed off and put into her staff file at this location.

General Comments

School age children were not present for today's monitoring inspection as they were still in school. Morning preschool program was inspected today.

When I arrived for today's monitoring inspection, all children were outside playing in their fenced in outside play space. Educators and children decided together to start off their day outside since the sun was shinning, and all the snow had melted from their outside play space! Children were observed playing with a bunch of toys, since an educator emptied out one of the toy bins to dry it out from the winter months. Other children were observed running around, hanging out under the colorful tires, and engaging with their educators.

When children moved inside the ELC facility, they were observed washing their hands and proceeded to have snack. The older group of children got to go and eat their snack in the school-age room today as a little treat. When they entered the school-age room, the chairs were still on the tables, please ensure that should this happen again that tables are properly sanitized before the children use them for snack. Educators were observed sitting with the children and eating snack with them.

Children were provided with toys in the quiet area to play with while they waited for the rest of their friends to finish snack. Once everyone was done eating, one educator sat with them to read them a story while the other educator cleaned the tables and swept the floors. Once both books were read, both groups got ready to head

back outside to explore the wooded area behind the ELC facility to see how much snow had melted in there!

Educators were observed always using gentle tones when speaking with the children during today's visit. They were also observed being attentive and interacting with the children.

Out of 4 preschool staff files that were inspected today, only 1 had evidence of completing professional learning hours. Please ensure that once staff who are working with preschool aged children complete either their ECE course or Intro to ECE online course, complete the required 10 hours of Professional Learning hours per licensing year. Conversation was had with all 3 staff to ensure they are aware of the PL requirement and informed them that they must keep a record of it at the Early Learning and Childcare Facility for inspection purposes. Should you have any questions regarding available PL courses that are being offered, please reach out with your consultant from the District Team.

Please ensure the recycling bin in the large bathroom is emptied today as it is beginning to overflow with recyclables.
