Comments: When I arrived at the Centre, the staff member was standing in between the doors of the two classrooms. She was heard saying to a child in an elevated voice and harsh tone: "sit down, put your boots on" she then said again, while pointing at the child "I said to sit down and put your boots on". Positive child guidance must be used at all times.			

<p><b>General Comments</b></p> <p>Soon after my arrival, the children got ready to go outside.</p> <p>The children went to play in the wooded area. There were no toys for the children and the children were asking for shovels. I asked the staff on two occasions if they had outdoors toys and the staff said they were in the playground. I suggested she take a group of children with her to maintain ratio and go get the toys because the children were asking. The staff did not go get the toys; therefore, the inspector went to get the bag of toys for the children. Toys should be available to the children outside, especially if they are asking for it.</p> <p>The children came back inside, wash their hands, and had lunch. Staff were observed helping children with their lunch and opening containers.</p> <p>The Centre is clean and organized. Different materials are available to the children, including materials in all mandatory categories such as art, science, math and literacy.</p> <p>The children's art is displayed on the walls.</p> <p>The afterschool children arrived at 2:30, they came inside, washed their hands and some had a snack and others went to play with the material of their choice. There was a craft activity set up for them on the table. The educators were engaged with the children, laughing with them and talking with them. One staff member was heard telling a child she appreciated all his help and thanked him. The staff were also observed checking on the children that were playing alone to ensure they were doing ok.</p>
