General Comments

Renewal Inspection:

Preschool Room:

Children and educators observed engaged in a variety of activities throughout the learning environment. Educators were observed engaging with children at their level and following the children's lead. Opportunities for exploring literacy and math were set up for the children. Materials that support the children's current interests have been added to the environment.

School-Age Room:

Children and educator were observed engaged in a variety of activities this morning/afternoon. The children were eager to talk about the bugs they had found when they returned from their walk.

Invitations were set up within each interest centre for the children to explore when they returned from outdoor play. The table in the dramatic play area was set up with a tablecloth, dishes and food. This invites children to engage in play and encourages children to value their environment.

Discussed ways to incorporate the children's emerging interests into the purposeful planning of day camps.

Hand washing routines were observed.

Recommendations:

- -Adding labels to bins (preschool room)
- -Adding photos of the children
- -Adding more opportunities for open art
- -Adding opportunities for painting daily (school-age room)

support the children's interests.

Surfacing under playground structure beginning to pool. Ensure surfacing is raked regularly to prevent surfacing pooling away from fall zones and bottom of slide.

Recommending that all Extreme Allergy Management Plans are reviewed, as some require updating and some allergies are unclear. All educators are to be well informed of children's allergies. This information should be

reviewed when new children transition rooms.

Immunization exemption form is only to be completed in cases where the child's parent/guardian refuses to immunize child or medical practitioner advises against immunizing. Ensure this form is completed properly and identifies which case it is, and if this is for a specific vaccine or all immunizations. This form is not to be used when a parent can not/will not provide immunization records to facility.
