<p><b>General Comments</b></p> <p>Monitoring Inspection to close orders for compliance ahead of Renewal Inspection. All orders are now complaint.</p> <p>Children and educators observed engaged in outdoor play this morning. The children were exploring a variety of materials for digging, dumping, throwing, pushing and pulling.</p> <p>The outdoor play area is well maintained and free from hazards. A new structure with two small slides has been added since last inspection. Recommendation - adding art and reading materials to outdoor play area.</p> <p>Purposeful planning is evident through documentation, invitations and materials added to the environments that support the children's current interests (food, nature, animals, camping, ocean and bugs).</p> <p>Monthly fire drills are documented.</p> <p>Daily attendance records in the 2/3s Room and 4s Room did not have all children signed in at arrival. Ensure daily attendance records are accurate and reflect all children present. Child-to-staff ratio was observed to be met during Monitoring Inspection.</p> <p>New staff file (4) review was completed; all required documents are in place. One staff member's First Aid is expired; staff is not to be left alone with children until complete.</p> <p>Facility is currently meeting the 50% trained Early Childhood Educators (4/6) requirement.</p>
