Comments: Washrooms: Washrooms were being shared between 2 separate groups without cleaning/sanitizing in between groups. Recommended designating specific toilets/sinks to each group within the washroom that is being shared by the 2 groups. Also recommended implementing a schedule for this washroom (ex: for hand washing before/after outdoor play and snack/lunch to prevent children from separate groups being in the washroom at the same time. This will require close monitoring and frequent reminders to the children. Washrooms should still be cleaned frequently. Group logs: The date group is established was being used as the actual date for the log. Discussed the difference with supervisor and educators on site.
