Comments: Licensing staff arrived at the facility on Friday, April 21st, 2023, to conduct a monitoring inspection. While conducting child-to-staff ratio in the classrooms, licensing staff noted new staff in a couple of the classrooms. While reviewing new staff files, it was noted that 3 staff files were not complete with the required documentation. Please ensure all new staff have certification in First Aid and Cardiopulmonary Resuscitation before leaving staff alone with a group of children.							

General Comments

Licensing staff arrived at the licensed facility to conduct a monitoring inspection on April 21st, 2023.

While observing in the classrooms, it was noted that new educators have been hired. While reviewing the new

staff files, three educators did not have a complete file with all of the required documentation.
Licensing staff observed larger groups divide up into smaller groups to help reduce the business of the larger groups. One smaller group sat down for snack while the other smaller group went outdoors to play. After approximately a half hour the groups would switch. Dividing the larger groups up really helped with the flow and business of the classroom in the afternoon.
After discovering the incomplete staff files, licensing staff attempted to reach a member of the management eam however, all attempts were unsuccessful. The acting supervisor was unsure where to find outstanding equired documentation for the staff files.
Recommendation:
to have one person on the management team who ensures that all required documentation is present in the staff files prior to the staff commencing employment as to avoid having to send staff home due to an incomplete ile.
