| <p>Monitoring Inspection:</p> <p>Children and educators observed engaged in a variety of activities this morning including outdoor play, mark making, dramatic play, sensory opportunities, stories, and painting. The infants were observed exploring markers, paint and glue with their educator. The children in the Twos Room were observed exploring a space water play invitation set out by the educators and working on a group jungle art project.</p> <p>Purposeful planning is evident through documentation on planning sheets, invitations and materials added to the environments to support the children's current interests (space, dinosaurs, construction, climbing, and kitchen/food). A kitchen area with real-life items has been added to the Infant #2 environment. Through discussion with educators in the Twos Room it was determined that the children in this room have been interested in climbing and that they spend quite a bit of time redirecting the children from climbing on furniture. Recommending adding a gross motor space with a small climbing structure to support their interest in climbing.</p> <p>Infant Rooms:</p> <p>QA Monitor noted that attendance records were left in the indoor play area during outdoor play. Ensure attendance records are taken with the group during outdoor play.</p> |

General Comments

Chilli, rolls and milk were served for lunch.
Handwashing routines were observed after outdoor play and before mealtimes.
Monthly fire drills are documented.
Daily attendance records are accurate and reflect all children present. Child-to-staff ratio was observed to be met during Monitoring Inspection. Infant Daily Information sheets observed to be completed throughout the day.
New staff file (5) review was completed, all required documents are in place.
Facility is currently meeting the 50% trained Early Childhood Educators (3) requirement.
An inspection of the school-age program will be conducted at a later date.
