Administrator immediately posted it on the facility door and classroom doors. Deficiency is now compliant

Comments: A cleaning product was observed in one of the classrooms. Toxic products, chemical products and cleaning supplies must be locked and inaccessible to children. Administrator immediately removed the product and stored it in a locked space. Deficiency is now compliant

The children were able to enjoy the nice weather during outside play. She was also able to observe children in one classroom do art with cooked spaghetti noodles and paint.
