I observed constant issues between two children who were close in age. Operator remained calm, positive, always giving gentle reminders on how to redirect undesirable behaviours. Operator was kind and caring towards children at all times during my visit.

Daily information sheets are being filled out properly and as day progresses.

Operator uses a minor incident log that is kept in each child's file. There has been no reportable incidents at this time.

Firearms are locked in operator's bedroom closet, in a cabinet that is bolted to the wall. The guns contain a trigger lock and bullets are stored in a crawl space.

Medications were not locked with an approved lock at beginning of visit. However, operator did move all medications into a locked box.
