General Comments						

Upon arrival the operator and 4 children greeted me at the door then we proceeded back to the playroom. Children had been building with blocks this morning. The operator encouraged children to help her with clean up as they were soon going to eat a snack. Afterward the children were supervised while washing their hands. The children enjoyed a yummy snack of yogurt, blueberries and granola cereal. Children were also observed eating lunch that they bring from home. The operator was observed with helping children with opening packaged foods.

The operator has a new puppy, and the children seem to really love her. She is a sweet pup and very friendly and loves the children. As per Public Health regulations ensure children's hands are being washed thoroughly after contact with the pet. The operator does keep a lead on the puppy and supervises the children when the dog is interacting with them. Please refer to PH regulations for further criteria. After snack children played hide and seek. Children were also observed in outdoor play during my visit. They enjoyed a number of activities - practiced walking on the balance beam, played with ride on toys, trucks etc. The forecast is high temp and humidex of 35 today, so the operator wanted to ensure children had some outdoor play time.

Administrative records were reviewed - attendance is tracked, infant toddler records completed, fire drills practiced, incident reports documented.

Just a couple of reminders to update your SD check and Fire extinguishers are due for servicing the end of September.

The operator has a wonderful rapport with the children - lots of interaction, conversation and engaged in children's play. She was observed assisting a child learning to practice her skills on the balance beam. The child felt confident enough to continue on her own.
