<p>General Comments</p> <p>A renewal inspection occurred today.</p> <p>The children were observed rotating between three areas of play. Each group took turns going outside, having snack, and playing upstairs. The children were observed in the upstairs area playing in the dramatic play area, building with blocks, engaged in art, as well as playing with magnetic blocks. The educator was observed allowing children to take part in risky play, helping children to resolve conflict independently, stepping in when needed, and was engaged in play with the children. The children were also observed in the breakout space having snack, playing catch with their educator, creating with perler beads, relaxing in the quiet area, and playing with playdough.</p> <p>The environment was set up with age-appropriate materials. Planning sheets were evident and posted for the educators and children to add to. Documentation of children's learning was displayed at the entrance and binder displayed with documentation that reflects the children's past and current experiences.</p>
