During the monitoring visit inspection on August 1 2019, there was no shade or shade structures in the approved licensed outside play space.

Comments: As set out in the Early Childhood Services Act and Licensing Regulations, an Operator is required to have an outside play area which consists of more than one surface to permit different types of play. During the monitoring visit inspection of the approved licenced outdoor play space, there is only grass for a play surface.

Comments: As set out in the Early Childhood Services Act and Licensing Regulations, an Operator is required to provide outdoor play area materials and equipment that are varied and in sufficient quantity for the number and ages of the children receiving services at the licensed facility. During the monitoring visit inspection for August 1 2019 of the approved outside licenced play space, the materials were not in sufficient quantity for the number of children in attendance, as there was only 2 small wooden child sized picnic tables, two large rubber bouncy balls and some wooden blocks.			

General Comments There is currently no shade in the facility's approved licenced outdoor play space, but the children were outside playing on the side of building where there is shade during my visit, they were exploring the trees and other natural materials.

General Comments

Educator has informed Quality Assurance Monitor that they do bring materials/games outside with them when they go, (example: large set of bowling materials).
