General Comments

Licensing staff arrived at the licensed facility to conduct the follow-up inspection visit on May 10th, 2022.

When licensing staff arrived at the licensing facility the children were engaging in free play activities before going outside for the remainder of the afternoon. The educators and children applied sunscreen before going outside in the sunshine.

Just before the children went outside, the educators took attendance to ensure all children were at the door to exit the building.

When inspecting the outdoor play area, licensing staff noted that the nails, in the wooden playhouse, were still protruding and remains unsafe for the children. On the day of the follow-up inspection visit, the educator closed off the wooden playhouse.

The operator sent along the First Aid and Cardiopulmonary Resuscitation Certificates and a Job Description, on April 19th, 2021, that were missing from the staff files on the day of the license renewal inspection visit.
