Comments: Some parts of the bathroom were cleaned but some stains and dirt remain and therefore, the bathroom needs more cleaning. If the stains in the toilet bowls cannot be removed, then the toilet itself needs to be replaced. If the stains on the seats cannot be removed, then the seat needs to be replaced. The walls/doors need to be washed, if the stains cannot be removed then the walls and doors need to be repainted. The ripped in the wall needs to be repaired and repainted. The countertop also needs to be repaired as bacteria can build up in cracked countertops. One toilet cover is broken and must be replaced.
