General Comments
<p>During the visit to Major Rooms 1 and 2, documentation reflected outdoor play, emotional expression, and dramatic play experiences. Educators reported that children were showing interest in cars, zoo and animal play, finger puppets, and dramatic play. Educators were observed remaining at children's level and consistently engaging with them throughout the observation.</p> <p>In Ellis Rooms 1, 2, and 3, educators identified children's interests as sound-producing toys, trucks, play animals, art activities, and the indoor jungle gym. The QAM observed children practicing scissor skills and interacting with toys that produced sounds, as well as animal figures. Documentation on the walls included nature-based invitations and learning experiences aligned with the children's interests.</p> <p>In Fox Rooms 1 and 2, educators reported that children were interested in music, books, animals, dramatic play, blocks, fidgets, and tent play. Documentation displayed painting activities, mirror play, ice exploration, and peek-a-boo experiences. The QAM observed educators singing with children and engaged in interactions.</p> <p>Across all rooms, child ratios were accurate and maintained, and parent boards were current and up to date.</p>
