Operator stated that the swimming pool that is in the yard is drained when children are in attendance. There is a piece of wood that is on the outdoor play structure that needs to be hammered in. Other than that, the sand has been tilled and meets licensing regulations.

Operator was able to demonstrate that children are engaged in activities. She has a binder with the children's artwork in it.

Some of the files were missing consents. Operator was able to have them completed at the time of visit as they were her grandchildren's files.

General Comments

I was able to verify attendance records. However, Operator was completing attendance records for this week at time of visit. Some of the children were not signed out on different days. Please make sure these records are accurate and complete at all times.
