General Comments
Licensing Staff arrived at the facility to perform a Monitoring Inspection. Upon arrival, the classrooms were bright, organized and welcoming. Natural light and several lamps were observed throughout the room, as well as plants and trees. Soft music was playing, and the children were engaged in a variety of activities spread throughout the room. As the children arrived, jackets and bookbags were hung up on hooks and any extra personal belongings were placed in the child's bin. A visual chart was observed by the cubbies. The chart had pictures of the children removing their outdoor gear, hanging up bookbags and putting on indoor shoes. Each child has their own bin where they can place their morning snack and water bottle. Inside the classroom the children were eager to show Licensing Staff their class pets, a hamster named Toast, and a fish named Fire. Throughout the morning the children were observed engaging in a variety of activities such as coloring, water painting and lessons in the practical life area of the classroom. An Educator played a song, and the children started to clean up the classroom before gathering together. The children sat with one Educator singing songs while another Educator cleaned the tables in preparation for lunch time. Hands were washed before the children began eating. Only positive child guidance was observed during today's Monitoring Inspection. The Educators encouraged independence and were attentive to the needs of the children. As a reminder, hot beverages must be kept in a spill proof container.
