<p>General Comments</p> <p>A renewal inspection occurred today.</p> <p>Educators were observed having meaningful conversations with the children, listening carefully allowing them time to think and express how they are feeling. Licensing observed flexible areas that are rich in opportunities for sensory learning, social interaction, language, exploration, manipulation, and representation. They are purposely designed and planned to enhance children's healthy development and learning.</p> <p>In the Tong room educators engaged in songs and dance with children. They read stories as the children had snack, washed hands and went for a walk around the neighborhood. Beautiful natural Art materials were set out as an invitation for the children to explore.</p> <p>The Bedard room was set up beautifully with open-ended invitations ready for the children to explore and wonderful documentation that reflects the children's learning. Children had the library program in reading a story to the children. Children were observed to be engaged and excited while listening to the story being read. Giving hugs to the readers when they were done.</p> <p>Fowler one and two had beautiful documentation using natural materials they collected on their walks. Fowler two went for a bear hunt using binoculars the children had made. The children all showed a sense of pride as they showed off their binoculars to licensing staff.</p> <p>All staff files and random review of children's files were complete.</p>
