General Comments
<p>Follow up inspection completed today. Most orders have been rectified, but some outstanding orders for compliance remain. Improvements were noted within the school age environment with respect to accessibility and variety of creative art materials. Ensure these are set up within the art area in an organized and inviting way each day. Some materials have been added to the infant outdoor play area, but more accessories are required for the mud kitchen.</p> <p>Some loose parts, small vehicles were noted in bins being stored outside the school age room for outdoor play.</p> <p>New staff on site today, files were reviewed. All staff have been registered to complete the 90 hour introduction to ECE course.</p> <p>A child was observed within the infant room trying to walk by holding and pushing a child size chair. Recommending the addition of a sturdy push toy with wheels to support gross motor development within this room.</p> <p>Signed statements for staff reviewed today-these need to be updated with the "Early Childhood Services Act." Operator must ensure that staff have reviewed the correct document.</p>
