Comments: Deficiency is now compliant There was no handwashing procedure sign posted in the blue bathroom on the preschool side. Educator was able to post sign at time of inspection.			

General Comments

When I arrived for today's monitoring inspection, the preschool children were observed partaking in quiet time activities, these activities included bracelet making with beads, playing with a farmhouse with animals, coloring/crafting, playing with a doll house and Little People, etc. After snack, preschool children finished their day outside.

School aged children were just arriving from school. Go-Go Leaders walk the children to the center once school is out, there is also another group that arrives via a Go-Go bus. School aged children went directly outside to play. Educators were observed ensuring children were applying sunscreen before heading off to play. Educators were also observed teaching some children how to apply sunscreen themselves.

School aged children were observed having snack outside. Educators were observed sanitizing the tables before children ate, they also ensured washed their hands before eating.

There is one umbrella that educators were unable to open at time of visit in the playground where the large slide structure is. Educator informed licensing staff that a work order has been put in. Please ensure to have the

umbrella fixed as soon as possible as summertime and the hot weather is quickly approaching.
Children's sunscreen is either stored in a locked cabinet or high on a shelf out of the children's reach.
