### General Comments

When I arrived one group was outside playing in the playground. There is an NBCC student who was doing an assignment and brought in a large book with blank pages , the book was on the ground with crayons and stickers and the children were creating on the pages.

In the morning program, when I arrived, the children were doing circle time and reading a book. Following book reading, the staff had set up two learning activities for them, one for matching pumpkins with the same number of dots and the other was tracing their names.

After the learning activities, some children had finished earlier than others, and the educator advised the children they could either take a book in the reading area or blocks/Legos. They had a few minutes to play and then the educator asked for them to pick up and said they would do a dance party and the floor is lava. As per section 7.1 Daily activities of the Operator Manual and Regulation 21(a), "children are provided with time and space for and a free choice of play experiences for exploration and discovery". During play time, children should be allowed to pick their own materials/activities and not be limited to only certain ones selected by the educator. Children must have access to all materials in their licensed space and move freely from one station to another.

The classrooms are clean and well organized with many different materials available to the children such as; arts and crafts supplies, blocks, cars, games, puzzles, different forms of literacy and more.

The educators were engaged with the children, sitting with them, and playing with them. They were seen provided positive child guidance such as encouraging words and positive reinforcement.

The playground was inspected and meets regulation. The children have access to outdoor toys and materials such as blocks, shovels, buckets and more.

I joined the staff as they went to get the children at the school. Staff ensured they did not leave the school without any children and called the main office to confirm absences. The children and staff walked back to the Centre, in a safe manner with staff at different parts of the line.

General Comments

Today was a hot lunch, children had spaghetti and a fruit cup.

Everything is in compliance, I recommend for renewal.
