Comments: The Quality Assurance Monitor observed two cans of Febreze in the play area and two containers of Luv Fresh air freshener in both bathrooms. The Quality Assurance Monitor informed the operator and educators, who immediately secured the products in a locked storage area. Deficiency is now compliant.			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (a) labelled with the name of the child.	40(1)(a)	Nov 24, 2025	Nov 24, 2025
Comments: After observing 2 water bottles without name labels, the Quality Assurance Monitor informed the educator. The educator immediately gathered labels, checked all water bottles and ensured that each unlabeled lunch box was properly labeled with the child's name. Deficiency is now compliant.

Comments: After observing three lunch boxes without name labels, the Quality Assurance Monitor informed the educator. The educator immediately gathered labels, checked all lunch boxes, and ensured that each unlabeled lunch box was properly labeled with the child's name. Deficiency is now compliant.			

<p>General Comments</p> <p>The Quality Assurance Monitor is on site to conduct a monitoring inspection. Child-to-staff ratios is maintained throughout the visit.</p> <p>During the inspection, the Quality Assurance Monitor observed children arriving from school, having snacks, playing on bouncy castles, engaging in a "fake snow" activity, and spending some time outdoors.</p> <p>A discussion took place with the operator regarding observations made during the visit. The Quality Assurance Monitor noted hearing a child repeatedly ask an educator when they would go outside, to which the educator responded that outdoor play would not occur. The Quality Assurance Monitor reminded the educator of</p>

General Comments

Regulation 22, which states that the daily routine of a licensed facility shall include

(a) at least one hour of outdoor play in each four-hour block when the majority of children are present, except when:

- (i) wind chill is below -20°C
- (ii) temperature is below -20°C
- (iii) temperature is 33°C or higher with humidity

The operator acknowledged that balancing outdoor play with planned activities can be challenging given the limited time children spend at the center. This led to a discussion about the day's activity—making fake snow with shaving cream and baking soda. While the activity was fun, the Quality Assurance Monitor observed that only four children participated and that it was primarily educator-led, with children mostly observing. The Quality Assurance Monitor suggested setting up materials (e.g., a large bowl of baking soda, saran wrap, shaving cream, smaller bowls and spoons) so children could lead the activity themselves and more could participate. The operator agreed that these suggestions would support staff.

The Quality Assurance Monitor also emphasized that while bouncy castles are exciting, they should not replace outdoor play. Instead of sending children to the bouncy castles when not engaged in an activity, they could go outdoors. The Quality Assurance Monitor noted that establishing a consistent daily routine would make outdoor play easier to implement. The operator agreed to work on revising the routine.

Finally, a discussion occurred regarding a staff member's use of comments that do not reflect positive child guidance. The Quality Assurance Monitor reminded the operator that there are better ways to approach children and that word choice is important when speaking to them.
