More building materials to be added to this area.</p> <p><b>Arts &amp; Crafts Area</b> More arts &amp; crafts materials to be added, including Paper, Glue, and Scissors.</p> <p><b>Dramatic Play Area</b> More materials to be added to Dramatic Play Area. A well-stocked kitchen was observed today, as well as one baby, puppets and a puppet theatre. A conversation to be had with children, asking about their current interests. More interest-based supplies and materials to be added.</p>			

<p><b>General Comments</b></p> <p>A Monitoring Inspection was completed this morning. Children were on a field trip to Saint John. At QAM's arrival, the children were on route to the Forest Playground and then later, the Minions Movie. The classroom and outside environment were observed today. Several forms of documentation were observed - colored photos of the children taking part in activities, an area in the cozy reading corner that captured photos of the children reading, and photos in the building area, showing off the children's creations. A conversation was had with Administrator regarding the materials in some of the centers. More materials, that expand on the children's interests, are to be added to the Building, Arts &amp; Crafts, and the Dramatic Play areas. The outside environment contained lots of fresh mulch. A reminder was given to ensure that mulch is raked each morning, ensuring the proper level of surfacing, under slides, swings, and monkey bars.</p>
