General Comments

A Monitoring Inspection occurred on April 28, 2025.

Children were observed during both indoor and outdoor free play. Proper handwashing was noted during transitions to indoor activities and before snack time. Steps or platforms were available to support children in reaching regular-sized toilets and sinks. Snack served during the visit was applesauce and graham crackers.

Educators shared that the children are currently interested in a variety of engaging activities, including participating in a self-created "kindness café," building with LEGO, dressing up in costumes for dramatic play, and being active outdoors on the playground. Indoors, children were also observed enjoying mini sticks and hockey games.

The facility maintains a daily incident log and allows parents of enrolled children to enter the center at any time. Outdoor play is provided when the majority of children are present and weather permits. Monthly emergency evacuations are conducted, and the license, inspection and monitoring reports, and any compliance orders are posted in a clearly visible location. The weekly menu is posted and includes substitutions as needed. Evacuation procedures are also posted in a prominent location.

A wide variety of appropriate equipment, materials, books, and toys were available throughout the facility. Several well-defined learning centers, including building, reading, dramatic play, and science, were observed. Drinking water is accessible throughout the day, and the outdoor stationary equipment is surrounded by protective surfacing of appropriate depth to ensure safety.

A conversation took place with the Administrator regarding the facility's strengths and areas for growth. Noted strengths included the cleanliness of the classroom and the use of photographs to document children's activities. Identified areas for improvement included displaying more pieces of children's artwork throughout the facility, addressing moments of disengagement when children arrive off the bus, and ensuring cleanliness is maintained after handwashing and before meals. A recommendation was made to transition directly to eating after handwashing to prevent children from becoming distracted, such as engaging in pillow fights on the couch area before meals.
