Children were welcomed back to their classroom to invitations of play in all areas of the room. Children were observed drawing, creating figurines using pipe cleaners and popsicle sticks, and playing hockey.

Children were observed having an open snack of trail mix and fruit salad. The children were able to eat when they wanted, which allowed children to be able to continue playing until they felt hungry, rather than being asked to eat at a specific time.
