General Comments						
Licensing Staff arrived at the facility to introduce themselves as the new Quality Assurance Monitor for the facility and to conduct a Monitoring Inspection. Upon arrival the children were in the process of being dropped off for the day.						
Children in the 4-year-old classroom were sitting at the table having morning snack. The children listened to an audio story about Dinosaurs as they ate. An Educator explained the children have been showing an interest in Dinosaurs lately. Evidence of purposeful planning was observed in the classroom. Several books, fossils and games about dinosaurs were on display throughout. Once the children finished eating morning snack, hands were washed and they prepared to go outside. Educators were observed offering help with boots, mittens and hats. Each child wore an orange safety vest over their snowsuits. A headcount was observed before transitioning to the outdoor playground.						
While playing outside the children were observed dancing to music, swinging on a tire swing, playing in the wooden playhouses and using shovels to scoop rocks into buckets. The Educators split the class during the transition period which made for a smooth transition inside for lunch. The senior infants transitioned inside first followed by the 2-year-old class. The Educators were heard praising the infants and encouraging their independence as they removed their outdoor wear.						
Hand washing and lunch time was observed in all rooms. The children appeared familiar with the daily routine and Educators. Only positive child guidance was observed during today's Monitoring Inspection. The Educators were attentive to the needs of the children and were actively engaged throughout the morning. Allergies were posted throughout the facility, and the posting board contained all required documents.
