Comments: Observed an educator change a diaper. Neither the child nor the educator's hands were washed, and the changing pad was not cleaned or sanitized after it was used.

Comments: Although the carpets are being vacuumed, they are not being picked up and swept underneath. Dirt in the corners of the rooms. The bookshelf in the afterschool room is falling apart and has in leaning it. There is also a shelf in two-year-old classroom that is wobbly and needs to be repaired or replaced. I also noticed a couple broken plastic storage bins that cracked and broken. The office chair in the afterschool room is ripped and wore out. This item needs to be removed from the room.

Comments: Tubs are being used to store some of the toys and materials. These items need to be on open shelves which will make the materials more accessible to the children.

Comments: Heard various comments from educators such as "Why are you still not dressed", "Sit here and do not move", "stop it", "don't give me your attitude, try me I have attitude too" and "oh my goodness you two, stop it" , " back it up a little, no (child's name) that's not what I meant; I don't like that" When children here lined up for outside and educator told the children "no playing in the water"			

<p><b>General Comments</b></p> <p>Purposely planned programming is evident in the facility. Although child guidance was a noncompliance licensing staff did observe positive guidance in the preschool and Two-year old classroom during transitions, especially getting ready for outdoor play time and lunch time. The educators were patient, asked the child questions to help figure out the issue and consoled the children to help them feel more comfortable and relaxed.</p>

Please remember the matts and carpets need to be cleaned underneath as well. A few shelves and storage bins need to be replaced as they are worn out and broken.
