The operator must ensure that all associated persons who are at least 18 years of age have a valid criminal record check in their file. The operator has 5 days to submit a valid criminal record/vulnerable sector check.

Comments: During the inspection, the inspector observed that a new management of potential illness form was signed by the parent. Deficiency is now compliant.

Comments: During the follow-up inspection the inspector observed that consent for administering medication is present in the 3 child files audited. Deficiency is now compliant.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (d) permitting the administration of emergency care to the child.	27(d)	Dec 20, 2023	Jan 18, 2024
Comments: During the follow-up inspection the inspector observed that consent for providing emergency care is present in the 3 child files audited. Deficiency is now compliant.

Comments: The administrator informed the inspector that no outings have occurred since that last inspection but that future consents will be maintained in the children's files. Deficiency is now compliant.

Comments: During the follow-up inspection the inspector observed that consent for permitting photographs and videos of the children for publication or social media is present in the 3 child files audited. Deficiency is now compliant.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (k) posting photographs of the child at the licensed facility to illustrate the child's learning.	27(k)	Dec 20, 2023	Jan 18, 2024
Comments: During the follow-up inspection the inspector observed that consent for posting photographs of the children in the centre is present in the 3 child files audited. Deficiency is now compliant.			
48(2) An operator of a licensed facility may supply food to a child receiving services at the licensed facility that a parent or guardian of the child brings from the child's home if the food is labelled with the child's name and refrigerated, as required.	48(2)	Dec 20, 2023	Jan 18, 2024
Comments: During the follow-up inspection, the inspector observed that all lunchboxes are labelled with the children's names. Deficiency is now compliant.
