The administrator stated that they have done one in June but likely forgot to document it. The Quality Assurance Monitor is on site for a monitoring inspection. During the monitoring inspection, the Quality Assurance Monitor verified these elements: Ratio and maximum number of children Administrative records Outdoor play area Outdoor play area materials and equipment Staff records The children played outside in the rain and were provided multiple opportunities to explore in the outdoor play area during the inspection. During the inspection, the Quality Assurance Monitor asked a staff member to see new staff member files. The educator stated they did not know where the files were located. The administrator was not in the facility when the Quality Assurance Monitor arrived for the inspection and when the Quality Assurance Monitor requested to see the documents. The educator called the administrator to inform them that the Quality Assurance Monitor was on-site and wanted to see some files. A few minutes later, the administrator was able to provide the Quality Assurance Monitor with the requested documents. The Quality Assurance Monitor recommends that the administrator show their new staff where documents are located to ensure that these documents are accessible
